



In case where the workmen employed by the contractor perform the same or similar kind of work as the workmen directly employed by the Principal Employer of the establishment, the wage rates, holidays, hours of work and other conditions of the services of the workmen of the contractor shall be the same as applicable to the workmen directly employed by the Principal employer of the estt. The same or similar kind of work, the same shall be decided by the Dy. Chief Labour Commissioner© whose decision shall be final.
- 6. In other cases the wages rates holidays, hours of work and conditions of service of the workmen of the contractor shall be such as may be specified in this behalf by the Chief Labour Commissioner©.
- 7. In every establishment where 20 or more workmen are ordinarily employed as contract labour, there shall be provided two rooms of reasonable diamentions for the use of their children under the age of six years. One of such rooms would be used as a play room for the children and the other as bed room for the children. For this purpose, the contractor shall supply adequate number of toys and the games in the play room and sufficient number of cots and beddings in the sleeping room. The standing of construction and maintenance of the crèches shall be such as may be specified in this behalf by the Chief Labour Commissioner.
- 8. The licence shall notify any change in the number of workmen or the conditions of the work to the Licencing Officer.

9. A copy of the licence shall be display prominently at the premises where the contract work

All Picence shall within fifteen days of commencement and completion of each contract NARWAR Submit a return to the Inspector appointed under Sec. 28 of the Act intimating the activity late of commencement, or as the case may be, completion of such contract work in

No female contract labor shall be employed by any contractor before 6.00 A.M. or after 7.00 P.M. provided that this clause shall not apply to the employment of workmen in pithead baths, crèches and canteens and as to midwives and nurse in hospital and dispensaries.
